- 2. All colleges may kindly note that all the required formalities to be completed at SPO level facilitating release of payments through PFMS SNA mode duly setting institution-wise drawing limits (First Phase) have all been completed. Therefore, the colleges may now start actually releasing payments through PFMS only against the pending or current payment proposals already approved by the SPO, duly following the procedure as required for releasing payments through PFMS.
- 3. It is also requested that the concerned suppliers/contractors whose payments are delayed due to PFMS related issues may not be referred to SPO. Instead, the concerned college may directly seek assistance of Central PFMS cell located in Secretariat Annex-II or p/o FC/RUSA or ICICI Bank officials or FC-cum-CSA/RUSA or RUSA Consultant, as the case may be, for addressing the technical/accounting issues that might come up in the course of disbursement of fund through PFMS.
